## February 12, 2013

## Meeting Notes

## Opening

Dina D'Ambrosi opened the meeting at 9:40AM. She directed everyone's attention to the emergency exits and then began the Pledge of Allegiance. She then introduced the guest speakers, Jim Gillespie and Craig Lanzner from Chartwells.

## Chartwell's - Jim Gillespie, Craig Lanzner

Craig Lanzner handed out February lunch menus. Jim spoke briefly about the lunch program. The program has not changed much over the 8 years that Chartwells has been providing lunches. However, the counts (number of students purchasing) have improved. Last month was an exceptional month. He added that many ask but there are no fried foods on the menu. He then fielded the following questions for 30 minutes:

1) Elizabeth Urbanski - Has then menu changed in response to Michelle Obama's guidelines? The response was no. The younger school menus have always been modeled after the National School Lunch program. The complaint that is most often received is the portion size. However, these sizes are required to meet the National School Lunch guidelines.
2) Elizabeth Urbanski - Is anything made on site? The response was that all preparation is done on site. However, many prepared foods (such as chicken nuggets) arrive frozen and they are heated on premise.
3) Mary Rice - Is the nutritional information (i.e, sodium etc) available? Jim told her to contact Craig Lanzner for this. Craig would most likely get this information from the Chartwells' dietician.
4) Judie Saunders - had some miscellaneous questions about the quality of ingredients. She first asked them why waffles were sold unheated in a cellophane bag. Jim responded that they come from the vendor frozen but they are heated in the bag on site. Second, she asked Jim to describe the whole wheat pizza. It is manufactured by an outside vendor but adheres to the National School Lunch guidelines. It is delivered frozen and is heated in the school kitchen. Finally, she asked for some examples of fresh fruit and salad. Jim replied that they have apples, bananas, pears, cupped fruit, and canned fruit. For salad, they have fresh chopped salad.
5) Debbie Brew - Why was spoiled/moldy milk sold at Indian Hill School? Jim Gillespie did not have an answer. He did say that milk is delivered twice each week.
6) Nicole DeSamo - Do you provide healthy snacks? Jim's response was that all foods fall within the nutritional guidelines and are approved by the Board of Education.
7) Judie Saunders - Do we have plans to exceed the USDA requirements? Jim's answer was no. However, he did say the USDA requirements have become more stringent during Chartwells' eight year tenure. Moreover, he anticipates that next year the USDA will come up with guidelines on a la carte items which will force removal of some items. He cautioned that this could have a financial impact. This statement stimulated some peripheral questions. Jim then explained what he meant by financial impact. The bottom line is that the food service is required to be self-supporting. That is all revenues must equal costs. And if the removal or change of items significantly impacts the counts (i.e., revenues), then something (e.g., price increase) would need to be done to correct the budget
imbalance.
8) Denise Kline - How are food allergies are handled? Jim responded that the parent notifies Chartwells and this information is logged in the POS (point of sale) system. This information will flash on the screen when child makes a purchase.
9) Mary Rice - How long does it take to purchase food? Jim responded that takes approximately 12 minutes to feed everyone. He added that biggest bottleneck is at the cash register because some students have no funds or cash in varying denominations (e.g. bags of change). If more children had money on account, it would take significantly less time.
10) Dennis Pavlik - Is the contact information on the Holmdel School's website correct? Craig said that if it is not, he will see that it is corrected. His contact is clanzner@holmdelschool.org.
11) Judie Saunders - If we raise the price of meals can we get better products? Jim's response was yes and no. If changing the products results in better food counts (revenues), yes. However, if changing the product results in decreased food counts, the answer is no. Moreover, studies have shown that knife and fork foods are not popular. Finger foods are the most popular.
12) Nicole DiSamo - Can milk be swapped for juice? Jim's response was yes.
13) Nicole DiSamo - Are all the food choices visible? Jim's response was yes. He also invited the parents to see the line after the PSA meeting.
14) Ana Vander Woude - Can the parents get more detailed information on what their children are purchasing? Right now many items are categorized as "Miscellaneous Side". Jim's response was that Chartwells was working on this with the point of service provider. However, they are reluctant to make any changes that will slow down check out.
15) Denise Kline - With respect to allergies, does the Chartwells' staff know what products contain potential allergens? Jim's response was yes.
16) Judie Saunders - Can we use recyclable trays? Jim's response was that we do not have dishwashing facilities so we cannot use reusable trays. However, we can provide cardboard trays but they are $3 x$ more expensive. This is what the South Brunswick district uses. They have an advanced recycling program.
Jim also (repeatedly) invited the parents to see the food line after the PSA meeting.

## District Student Directory - Theresa Slade

Theresa Slade gave a brief overview of the Holmdel District Student Directory in hopes to solicit a volunteer to apprentice and then ultimately take over this position.

The highlights of her presentation are as follows:

- The directory comes out annually (in the fall). It contains the names addresses, and phone numbers of all students in the district who elect to be included. (Parents who chose to be included enter the information online.)
- The directory has been around for 17 years and Theresa has been spearheading it for the past 7.
- It is a job that can be done from the home and only runs from 9/1 through 10/31 each year.
- They use a district parent, who is a printer, for the printing.

Theresa then passed around a sign-up sheet.
Judy Rabkin asked if email addresses can be included in the directory. Theresa said she would take this into consideration.

## Principal's Report - Brian Schillaci

Mr. Schillaci first reported that there was a Pre-K information Session last Thursday evening ( $2 / 7 / 2013$ ). If anyone who is interested missed the presentation there are packets in the office. In addition, information is contained in the following link:

Second, Mr. Schillaci reported that Kindergarten Registration will be on Tuesday February 26, Wednesday February 27th and Thursday February $28^{\text {th }}$. For more information, see the following link: http://www.holmdelschools.org/schools/village/pdf/kdg reg news 2013.pdf
Third, Mr. Schillaci reported that Read Across America would run the week of March 4. There is a committee of 12-13 people putting together a weeks worth of fun filled activities capped off by an assembly.

Fourth, he reported that the safety committee continues to meet. Any developments from this committee will be communicated with e-alerts.

Fifth, and finally, he talked about Village Idol. Village Idol is a benefit put together by the Village Staff to raise funds for the schools impacted by super storm Sandy. There will be two performances on 2/22/2013 at 5:00PM and 7:00PM. The PSA will be supporting the staff with ticketing, logistics, $50 / 50 \mathrm{~s}$ etc. The staff is both excited and nervous.

PSA members then asked Mr. Schillaci questions about the new class party policy. Specifically, Ana Vander Woude, Denise Kline and Sandra Szilasi asked if there was any way the safety committee would consider allowing more than 5 parents per party. They suggested staggering the parties or making the parents preregister. Mr. Schillaci said he would take it back to the committee. However, he cautioned that if an emergency were to occur during these parties, there could be 300+ more people to account for.

Mr. Schillaci also repeated that he appreciates all feedback.
Debbie Brew then asked if there would be limit of 5 at Field Day. Mr. Schillaci responded no. Because that event takes place outside the building, there will be no limit.
Darlene Kiss reported that some of the roofing contractors were in the building with out identification. Mr. Schillaci conceded this was a problem.

Dennis Pavlik commented that we need to work on emergency procedures for parents in the building.
Mrs. Barbara shared that she had been asked "what should parents tell their children to do in an emergency?" Her response was "listen to the teachers and staff members". Similarly, she told parents if they are in the building in an emergency, listen to the teachers and staff members. They know what to do.

## Assistant Principal - Jessica Vierschilling

Mrs. Vierschilling opened by saying the good behavior program lunch program she implemented and discussed last month is going great.

She then shared that the next big thing she will be addressing is behavior on the buses. She expects to reach out to parents on this. Dina then offered the PSA's bus safety committee to work with her.

In closing, she reminded parents that she welcomes feedback and is accessible to all.

## Teacher Representative - Christine Barbara

Mrs. Barbara opened by saying that the entire staff is excited and panicked about the Village Idol show. In addition, they were impressed by all the support the PSA provided.

Second, she reported that the Sandy Hook quilt was completed. (Kara Devaney passed around a photo.) Mary Simpson ( $1^{\text {st }}$ Grade teacher) did an excellent job. The staff and the PSA executive board signed it.

## Teacher Representative - Kara Devaney

Ms. Devaney thanked the PSA for the Market Day tasting on 1/29/2013.
She then shared the artwork (done by a Village School second grader) that will be featured on the Village Idol program.

## BOE - Ana Vander Woude

Ana shared that there have been two meetings ( $1 / 9$ and $1 / 30$ ) since the last PSA meeting. At the January $9^{\text {th }}$ reorganization meeting they welcomed the newly elected members and voted on new leadership. The new BOE president is Ana Vander Woude and the Vice president is Dennis Pavlik.

## What is Otoludel Odelps?

Unknown to many in the state, the one-square mile Borough of Keansburg was devastated by Super Storm Sandy. This Monmouth County borough of about 11,500 residents saw nearly 1,900 of their homes damaged by the storm, many severe enough to be declared uninhabitable, many more requiring extensive repair before families are allowed to return to them. Keansburg is a community made up of many low to middle income families who will have great difficulty financing such costs. Even now, months later, about half the borough's residents are not living in town. The pressure on these families and the Borough's administration is tremendous.

So with that in mind, the Township of Holmdel has
 partnered with the Borough of Keansburg to help in any way we can to assist in their efforts to rebuild and restore the town. Holmdel Helps is a team put together by Holmdel Mayor Pat Impreveduto to drive this effort. The team's members represent the Township's Administration, boards and committees, residents and students of Holmdel and numerous community organizations.

On March 1, 2013, Holmdel Helps is hosting a fundraising event at the Lakeside Manor in Hazlet with the goal of raising $\$ 100,000$ to be used to directly purchase core building materials for the residents of Keansburg. These materials will be purchased at national retail chains and will include preapprove items such as lumber, sheetrock, insulation, roofing, wiring and more... items needed to put a roof back over the heads of these families in need. One hundred percent of monies raised will go towards these purchases.

Only owner-occupied primary residence homes found on Keansburg's list of storm-damaged homes will be eligible (no rental properties). Residents will need to submit an application to Keansburg, and will be processed on a first come first served basis. Each eligible homeowner will be considered for "Holmdel-Donated" (ie. free) home-building materials worth up to $\$ 5,000$ maximum per home. Our goal is to help as many residents as possible get started on their way to returning home.
